

Permanent Residence The Economic Classes



To obtain Permanent Residence in Canada, there are programs that determine your personal skills, your investor potential or your family relationship with a Canadian Citizen or Permanent Resident.

Economic Classes

This is the most popular option to come to Canada. The Canadian Government has the goal of inviting each year hundreds of thousands of qualified immigrants from around the world, based on their personal profile and qualifications. The options available in the Economic Classes are:

• Federal Skilled Worker Class

This option is available for professionals with excellent command of English or French, work experience and in the right age.

A job offer can help, but is not a requisite.

• Federal Skilled Trades Class

This option is available for Certified Trades People with good command of English or French, work experience and the right age.

A job offer can help, but is not a requisite.

• Canadian Experience Class

Available for those who have worked at least one year in a professional job in Canada and have good English.

Ideal for those who have studied in Canada or have been hired by a Canadian Company.

• French Language Proficiency

Available for people with a French Level of 7/10, Around B2.

A competent level of English is also required.



Sponsorship of Spouses or Common Law Partners by Canadian Citizens or Canadian Permanent Residents

Canadian Citizens or Permanent Residents are authorized to sponsor their spouses or common law partners so they can become Permanent Residents too.

The Canadian Citizen or Permanent Resident must be married or in a Common Law Relationship with the Foreign Citizen that will be sponsored.

A Common Law relationship is defined by Canadian Law as two people living together, for at least one year in a conjugal relationship.

In Breaktime we have helped many couples from different backgrounds to obtain Permanent Residence through this process.

Sponsorship of Parents or Grandparents by Canadian Citizens or Canadian Permanent Residents

Canadian Citizens or Permanent Residents are authorized to sponsor their parents or grandparents so they can become Permanent Residents too.

This is an important part of the commitment of Canada to reunite families in this country.

Canadian Immigration Laws promote family reunification, allowing citizens and permanent residents to sponsor their family members



Provincial Programs

The Government of Canada allows each province to manage their own Immigration Programs based on their specific needs.

Most provinces offer options for:

- Investors
- International students that have completed university or College in Canada
- Professionals of certain fields that are in demand inside the province

To qualify, in most cases, the applicants have to be working or have received a job offer from an employer in their province.

Receiving Sponsorship from a Province has a very possitive impact in applications for Permanent Residence.

Pilot Programs

The Canadian Government puts
Pilot Programs in place to help Canadian
Families, Companies or Regions with their staff
needs.

Some of these programs are designed to help a Canadian Region or Province to get people, that are needed urgently to keep certain sectors of the economy working,

Other programs are designed to help obtain Permanent Residen to people that are working or can come to work in some specific occupations that are urgently needed.

The types or programs offered are constantly evolving, so you need to contact us for information about what is being offered.

Receiving the Sponsorship from a Canadian Province gives people an enormous boost in their chances to qualify for Permanent Residence



Being able to obtain the Canadian Citizenship is certainly one of the most important and possitive changes that you can make in your life.

We can help you process your Canadian Citizenship if you are a Permanent Resident of Canada.

Once you have become a Permanent Resident of Canada, you will need to live in this country for three years to be elligible to claim Canadian Citizenship.

Citizenship will be granted to all Permanent Residents that apply for it and that do not have a reason to be considered inadmissible, such as criminality, terrorism or participation in activities against human rights.

There are many advantages in obtaining Canadian Citizenship, such as:

- Being able to apply for a Canadian Passport
- Being able to vote or be elected
- Being able to live in another country for as long as you want without losing your Canadian Citizenship

Canada also allows its Citizens to have multiple nationalities.

By adopting the Canadian Citizenship you will not lose your other nationality, unless your country does not allow it.

Having a Canadian Passport makes your international travels easier and opens the doors for work mobility programs around the world

Visitor, Study or Work Permits





• Visitor Visas.

Necessary for people who come from countries where a visitor visa is needed.

Please contact us to check if you will need a visitor visa to come to Canada.



• Study Permits

Necessary for all students coming to Canada for more than 6 months.

- If you study a professional program, you will be automatically authorized to work while your study.
- Students who take a 2-year university program can apply for a 3-year Post Graduation Work Permit.
- Studying certain educational programs allows students to bring their spouses and children.



Work Permits.

Necessary for everyone who wants to work in Canada.

There are different programs that allow Canadian companies to recruit international talent, either by international labour movement agreements or by requesting the Canadian Government to authorize the contract of a foreign worker through a Labour Market Impact Assessment (LMIA)



International Students obtain multiple benefits, like receiving a work permit, bringing their families to Canada and applying for Permanent Residence and Citizenship.

Every student that enrolls in a professional studies program receives a Work Permit.

This helps in covering living expenses and getting international work experience.

Students who complete a professional program in certain academic institutions can request a Post Graduation Work Permit.

Students registered in certain Professional Programs can come with their partners, who will receive a Work Permit, and can also bring their children, who can study for free between kindergarden and 12th Grade.

After obtaining the Post
Graduation Work Permit,
students can stay in
Canada for up to 3 years.

After one year working in Canada, most students already qualify for Permanent Residence.

Canada has immigration programs that facilitate the application process to international <u>students</u>

Benefits

Labour Market Impact Assessment (LMIA)



Canadian companies can hire international workers that have characteristics that are difficult to find in Canada, or whenever there is a shortage of workers in specific industries. Hiring international talent has many benefits for employers and is a great opportunity for foreign workers willing to come to Canada.


Benefits for Canadian Employers

- Can hire high quality professionals with the right studies and work experience.
- Hire extremely talented people without having to compete for them in the Canadian job market and without paying higher wages.
- LMIAs allow foreigners to work only for the sponsoring company for up to 3 years. Much less staff turnover.
- Easier to fill positions that require on site work and work with characteristics that can deter local employees.

Benefits for International Workers

- Will have access to live in Canada and experience its high standards of life.
- After working for 1, 2 or 3 years in Canada, workers and their families can apply for Permanent Residence.
- Workers can bring their spouses who will receive an open work permit and their dependant children who can go to school for free between Kinder and Grade 12
- Will be paid salaries that are competitive and will have access to Canadian social benefits.

Hiring international workers is a Win - Win situation for both Canadian employers and for foreigners willing to move to Canada
